Information profiles must be no longer than 200 words in length and must be submitted to the Returning Officer as Microsoft Word compliant document either by email to [nswelections@aec.gov.au](mailto:nswelections@aec.gov.au) or on CD, not later than 12 pm (noon) Australian Eastern Daylight Time (AEDT) on 24/02/2020.

The ballot, if required, will open on 25/03/2020 and close at 10:00am Australian Eastern Standard Time (AEST) on 15/04/2020.
